ORDINANCE NO. 2024-7

AN ORDINANCE ESTABLISHING THE PAY RATES AND RANGES FOR THE SEASONAL AND RECREATIONAL EMPLOYEES AND DECLARING IT AN EMERGENCY

BE IT ORDAINED by Council for the City of Delphos, Allen and Van Wert Counties, State of Ohio that,

SECTION ONE: The appointing authority for all positions shall be the Board of Control for the City of Delphos, Ohio.

SECTION TWO: The hourly pay for the Pool Manager shall be \$14.00 to \$17.00 per hour

SECTION THREE: Hourly pay range for lifeguards, pool staff and concession stand employees are as follows:

Deck Managers : \$13.00 to \$15.00 based on years of service in that position
Lifeguards: Minimum Wage to \$14.00 based on years of service in that position
Pool Staff (includes concession stand, gatehouse, slide personnel): \$7.00 to state minimum wage based on years of service in that position.

SECTION FOUR: The hourly pay range for SEASONAL EMPLOYEES in the Park Department is State minimum wage up to \$14.00 per hour.

SECTION FIVE: The City may on contractual basis hire specialized instructors and groundskeepers for programs. The contract price shall be pre-determined and entered into the minutes of the board of control.


SECTION SIX: The hourly pay range for SEASONAL EMPLOYEES in the Maintenance, Water and Sewer Department shall be State Minimum Wage up to \$14.00 per hour.

SECTION SEVEN: Any seasonal or recreational employee who does not fall under the Fair Labor Standards exemption shall be paid state minimum wage.

SECTION EIGHT: This ordinance hereby repeals ordinance 2021-23, 2022-15 and any other ordinances inconsistent herewith.

SECTION NINE: This ordinance shall be declared an emergency measure necessary for the preservation of public peace and welfare and in order to have rates established for employment.
