AN ORDINANCE AMENDING CHAPTER 925 OF THE CODIFIED ORDINANCES OF THE CITY OF DELPHOS REGARDING WATER RATES, RULES AND REGULATIONS AND CHAPTER 921 REGARDING SEWER RATES

WHEREAS, Section 921.10 (k)(3) and 925.09 (i) of the codified ordinances of the City of Delphos state "A CPI rate adjustment shall be presented to council by the Auditor in ordinance form each February for consideration regarding water and sewer rate increases. The rate adjustment shall be a percentage equal to the previous calendar year's percentage change in the Consumer Price Index (CPI) and shall be effective with the May billing in each calendar year." The CPI increase is 5.2%.

BE IT ORDAINED by Council for the City of Delphos, Allen and Van Wert Counties, State of Ohio that, SECTION ONE: Section 925.09 (a)(1) monthly rates be amended to read as follows:

SECTION TWO: That Section 921.10 k(2) be amended to read as follows:

(1) Sewer Service Charge. Effective with the May, 2024 billing, sewerage service charges pursuant to this section shall be billed monthly and shall be subject to a service charge of Nine and 38/100 (\$9.38) per month, per consumer unit. Any portion of a month will be billed at the current minimum monthly charge.

(2) Sewer Usage Rate.

- a. Sewerage usage rates shall be \$0.1106 per cubic foot for 0-167,000 cubic feet and billed monthly.
- Sewerage usage rates shall be \$0.1074 per cubic foot, billed monthly for industrial users in the range from 167,001 cubic feet and over.

SECTION THREE: These changes shall be effective with the May 2024 utility bill.

SECTION FOUR: This ordinance shall be in full force and effect from and after the earliest period allowed by
